  - A *Physical Certificate Deposit: Stock Waiver* form is required if the registration on the account and the certificate are not the same.
  - If the certificate or account is owned by an entity such as a trust or estate, include documentation to verify your authority to sign.
  - A *Physical Certificate Stop Release Letter* form is required if a "stop" was placed with the transfer agent for a certificate.
