5. The Company assumes all responsibility for safeguarding account information, including any account credentials, and any actions taken by Authorized Account Users.

The Company hereby indemnifies and holds Chase harmless from any and all loss, damage, or liability incurred due to: (a) the inaccuracy of any of the statements contained herein; (b) the Company's failure to fully perform under any agreement between the Company and Chase; and (c) any actions or omissions taken by the Authorized Account Users with respect to the Account.

6. REVOCATION: Chase is authorized to act in reliance of this instrument until it has received a written notice of revocation and has acknowledged receipt of such notice in writing.
